





The Muddy River Restoration Project is a joint project of the City of Boston, the Town of Brookline, and the Commonwealth of Massachusetts. It is funded with federal, state and local money, and designed and managed by the US Army Corps of Engineers.


The Project has five inter-related objectives:

- 1. Control flooding;
- 2. Improve water quality;
- 3. Restore landscape and other historic resources;
- 4. Enhance aquatic and riparian habitat; and
- 5. Institute best management practices with respect to stormwater management through out the Muddy River watershed.




## Muddy River Restoration Phase 2 Phase 2 Project Area Overview

### Sediment processing at Agassiz Rd.


Three stages of material processing:

- middle area sediment that is in the amendment mixing stage; and
- far side processed sediment that is stabilized, ready for shipment to the final disposal facility.

### THE MUDDY RIVER RESTORATION PROJECT MAINTENANCE AND MANAGEMENT OVERSIGHT COMMITTEE

The MMOC is an independent oversight body, established by the Massachusetts Secretary of Energy and Environmental Affairs, to help to protect the Commonwealth's significant investment in the Project. It provides independent evaluation of the Project in order to ensure full compliance with all environmental requirements and proper long-term maintenance of the Project area. It is serves as the formal vehicle for public participation in the Project. It is funded by Boston, Brookline, and the Commonwealth's Department of Conservation and Recreation.

The MMOC's members include citizen activists deeply committed to protecting urban parks and open space, and representatives of advocacy organizations and governmental agencies involved in the Project. Organizations serving on the MMOC include Brookline Greenspace Alliance, Charles River Watershed Association, Emerald Necklace Conservancy, The Fenway Alliance, and MASCO, the Medical, Academic and Scientific Community Organization for Boston's Longwood Medical Area.
